Bank Foreclosure:

40 accounts have not paid their 2023 assessment in full. Past due statements continue to go out each month. First warning notices do not go out until April.

Damon Heemstra gave a report on the financials and the status of the operating account:

- 16% of the year is completed and the Association has spent 13.3% of the operating budget.
- 86.1% of the annual dues has been collected.
- All previous discussions about realigning the budget lines to match the forecasted expenditures has been corrected and updated.
- Only area of concern is: Utilities 6010 Electric. The Association is running a little high and its more than the 8% that is budgeted each month.
